By indicating your acceptance, you understand, agree, warrant and covenant as follows:

I understand the rules, conditions and regulations of the event and agree to comply fully with said rules. I also understand that said rules are subject to change at any time. Minor applicants (under 18 years of age) may participate with parental consent or that of a legal guardian. I have been advised that I should not participate in this event unless: a) I am in excellent physical condition and b) have trained for the distance. I have also been advised that I may be exposed to physical injury from a number of natural factors, including possible debris on the course, lightning, rain, hail, sleet, freezing rain, snow, flooding, road damage, automobile traffic, farm equipment, livestock and wildlife, among other things, and to the hazards of bicycles and/or vehicular traffic, and to those other hazards attendant upon running across or along roadways. Runners are required to obey all traffic control signals, signs, and officials.

Knowing these facts, I nevertheless, in consideration of accepting this entry, hereby for myself, my heirs, executors and administrators, assume all risk of participating in this running event and waive, release, and discharge the Jackson Hole Chamber of Commerce, Dreamchasers Outdoor Adventure Club, LLC, including their members, sponsors and volunteers, the Town of Jackson, Wyoming, Teton County, Wyoming, The State of Wyoming, Teton Village Association, Jackson Hole Mountain Resort, Presbyterian Church of Jackson Hole, any official race sponsor entity and the officers, directors, shareholders, members, agents and employees of each, all medical and other personnel, whether paid or volunteer assisting with this running event, their representatives, successors and assigns, from any and all rights, claims or liability for damage for any and all injuries to me or my property, or for damage caused by me or by anyone else (including Acts of God), arising out of or in connection with my participation in this event. I further agree that I will defend, indemnify and hold harmless the Jackson Hole Chamber of Commerce, Dreamchasers Outdoor Adventure Club, LLC, including their members, sponsors and volunteers, the Town of Jackson, Wyoming, Teton County, Wyoming, State of Wyoming, Teton Village Association, Jackson Hole Mountain Resort, Presbyterian Church of Jackson Hole, I Am Athlete, LLC ("imATHLETE"), and any official sponsor entity and the officers, directors, shareholders, members, agents and employees of each, against all claims, demands and causes of action, including court costs and attorneys' fees directly or indirectly arising from any action or other proceeding brought by or prosecuted for my benefit contrary to the Agreement. This release extends to all claims of every kind and nature whatsoever, whether known or unknown. Participant must complete their race and be off the course by 1:30pm (6.5 hours). Any runner still on the course after that time MUST follow all state and local traffic signals, and will be proceeding at their own risk. Additionally, there will be intermediate cut-offs along the course - please check the Rules and Regulations on the official race website for details.

The undersigned grants his/her irrevocable permission to the Jackson Hole Marathon Events, and any media outlet covering the event, and the sponsors, authorized agents, contractors and representatives of each, to use the under-signed name and likeness in any photographs, video footage, motion pictures, recordings or any other records of the undersigned's participation in this event, for any purpose. I understand that this waiver includes any claims, whether caused by negligence, the action or inaction of any of the above parties, or otherwise. I expressly acknowledge that I have read this entry form in its entirety and that I understand and agree to be bound by the terms and conditions set forth herein.
